HUNTS COURSE RULES AND CONDITIONS

1. All trainees are to read these Rules and Conditions and sign the Trainee Application Form to signify that they will abide by them at all times. These rules are design to help ensure your safety and enjoyment when attending a HUNTS Course.
2. All applicants must be a financial member of NZDA North Auckland Branch or another NZDA Branch by invitation only.
3. The minimum age of trainees is 16 years and their parents or guardian's consent must be obtained in writing if they are under the age of 18 years.
4. All trainees must produce their firearms licence prior to attending the course, unless prior arrangements are made with the HUNTS Coordinator.
5. The top priority at all times is firearms safety.
6. Any trainee without a firearms licence shall be under the immediate supervising of an instructor or another firearms licence holder whenever they are handling a firearm. The instructor / licence holder concerned must not be using a firearm while supervising a trainee.
7. All firearms that are to be used on the course must be inspected and accepted by an instructor and semi-automatics are only permitted at the discretion of the HUNTS Coordinator.
8. Only one centrefire rifle per trainee shall be taken on any field trip.
9. All instructors and trainees are to act in a safe, responsible, respectful manner at all times and trainees are to follow the instructor's directions at all times, especially in an emergency situation.
10. No instructor or trainee shall at any time use language or behave in such a manner as to be offensive, disruptive or discriminating.
11. To ensure the safety of the group, all medical conditions or physical disabilities must be declared prior to commencing the course and any recent physical injury or illness must be declared prior to a field trip.
12. Young or inexperienced trainees must be supervised at all times. They shall never be left alone or allowed to go off on their own. The coordinating instructor shall determine the level of supervision required for older trainees.
13. No instructor shall be supervising more than 4 trainees at a time with firearms while on a field trip.
14. All trainees must attend a briefing prior to any field trip and may need to have their gear checked by an instructor.
15. When hunting in a group, only the person in front should be in a state of semi-readiness and all other firearms must be unloaded.
16. No dogs are permitted on the rifle range or on field trips.
17. No alcohol or drugs are permitted on any course activity, apart from prescription medicines or special medications required by the trainee.
18. All indoor training environments shall be smoke free.
19. All trainees shall endeavour to protect the environment and abide by the Department of Conservation Environmental Care Code.
20. All incidents that breach these Rules and Conditions or cause an injury, must be reported to an instructor or the HUNTS Coordinator.
21. Any breach of these Rules and Conditions may result in the trainee concerned being removed from the course, at the discretion of the HUNTS Coordinator or the Branch Committee.
